She will be making the arrangements for fund-raising, registration/ information desks, partnerships, entertainment/refreshments, prizes, child care, parking, alternate hotel/ housing for out-of-town players, transportation guides, restaurant/ tourism guides, and so forth, so that next year's Summer Nationals are equally successful. Margot will announce the name of the volunteer coordinator shortly, so be thinking about how you can help.

Another major interest of mine during this next year is our Education program. Particularly exciting right now are the bridge classes in progress at the Smithsonian as part of its summer program. My goal is to provide an atmosphere for all of us that is both fun and challenging.

### Round Robin for 2001-2002

### Unit Game Updates by David Gottfried, Chief Unit Director

Everybody comes up against the occasional difficult hand that takes a few minutes longer to play, but it seems that slow play is becoming more prevalent at many club games around the Unit.

It's difficult to imagine that taking an extra five minutes for a round could have far reaching implications on the entire game, but it does. I have been receiving an increasing number of complaints lately about slow play (either following a slow pair or constantly having to wait because of the bottlenecks created when a pair cannot complete a round within a minute or two of the allotted time). One slow pair affects their immediate opponents, their next opponents, and the pair waiting to come to their table. The unfortunate consequence of falling behind early in the game is that it often is very challenging to catch up.

Directors have a good deal of empathy for delays caused by emergencies and the occasional difficult hand, but little or no tolerance for players who exacerbate the problem by not making a good faith effort to get caught up. The following suggestions may help:

1. Don't engage in any post-mortem during the round—defer it until the end, and then only if you are caught up.

2. If you are on opening lead, it is a matter of courtesy to make the lead before recording the contract on your card or on the pick-up slip if you are sitting north.

3. If you are following a slow pair, be ready to move to the table as soon as the round is completed—it's not helpful to go for a cup of coffee or out to smoke just because it is expected to be a few minutes before your new opponents are ready for you.

4. Don't return late from breaks. The Unit Game utilizes a clock that displays both the round number and the remaining time in the round. Players who return late (often to find their opponents seated and waiting) and state "Don't worry, we play fast" are being discourteous to the opponents, who have a right to the entire time for each round.

The NVBA expects the Unit Directors to issue warnings for first offenses and procedural penalties for pairs who are unable to get caught up. While the importance of doing your part may seem trivial, duplicate bridge is truly a choreographed event, and all players can and should do their part to ensure that everybody enjoys the game.

# **Unusual Over Unusual**

"Unusual over Unusual" is a competitive bidding tool for use against two-suited overcalls. By defining the cue bids of both of the overcaller's suits, it allows opener's side to distinguish between limit raise values in opener's suit and a competitive raise in opener's suit, and also to distinguish between limit raise values and a competitive bid in the remaining unbid suit. It is a simple and efficient tool, and I recommend adding it to your competitive bidding toolbox.

Here is a simple example from the NVBA Unit Game on June 14th. In first seat with none vulnerable, I opened 1▲ holding ▲AKQT2 ♥94 ♦ J932 ♣A6. LHO bid 2NT (minors). Partner bid 4♠ with ♠J853 ♥AO87 ♦ AT ♣T83. (We were not playing Unusual over Unusual.) I passed and made 5 after  $\bigstar$  k lead, a very normal result. Afterward partner asked if she should have bid differently. That question encouraged me to write an article on Unusual over Unusual because the hand provides a classic example. Playing Unusual over Unusual, she would bid 3 ♦ showing a limit-plus spade raise. (I'll explain why  $3 \blacklozenge$ , and not 3\*, later.) Knowing the limit-plus raise at the 3-level would have allowed me to investigate slam if I held a slightly better hand (for example, replace the  $\checkmark$ 9 with the  $\checkmark$ K).

### When It Applies

As with many competitive bidding conventions, the key point is knowing when it applies. Unusual over Unusual *only* applies when the opponents have shown two *specific* suits. It does not apply when they have shown one specific suit and another unspecified suit.

Unusual over Unusual applies after the following sequences:

• Partner opens 1 of a minor (1m) and RHO bids 2m (Michaels for the majors)

• Partner opens 1 of a suit (1y) and RHO bids 2NT (Unusual for lower suits)

• Partner opens 1NT and RHO makes a two-suited overcall showing two specific suits, such as 2♦ showing both majors (Cappelletti) or 2♥ showing both majors (DONT)

• • By extension, any other situation where partner opens and RHO makes a low level overcall showing two specific suits.

### When It Does Not Apply

Unusual over Unusual does *not* apply after the following sequences:

• Partner opens 1 of a major (1M) and RHO bids 2M (Michaels for the other major and an unspecified minor)

• Partner opens 1NT and RHO makes a two-suited overcall that does not specify both suits, such as 2M (Cappelletti—showing that major and an unspecified minor) or 2 ♦ (DONT showing diamonds and a major)

I recommend you handle twosuited interference in which the opponent shows one specific suit (let's call it an "anchor" suit) and another unspecified suit as if the overcaller had bid the anchor suit naturally. Therefore, all your regular tools are available, such as cue bids showing limit plus raises after 1 of a suit openings and Lebensohl if partner has opened 1NT.

### **How It Works**

The basic premise of Unusual over Unusual is that you define the cue bids of the overcaller's two suits as limit plus values either raising opener or with 5+ card length in the remaining suit. The common and simple way to play it is: the higher ranking cue bid is for the higher suit, and the lower ranking cue bid is for the lower ranking suit, regardless of whether opener bids the higher or lower suit. Since invitational hands use the cue bids. 3-level raises and bids of the remaining suit are merely competitive, not invitational. NT bids are natural. Doubles are penalty oriented with the willingness to penalize at least one of overcaller's suits.

A series of examples will quickly eliminate any confusion.

**First.**—Let's say partner opens 1 **4** and RHO overcalls 2 **4** (Michaels for majors).

•  $1 \div - 2 \div - 2 \bigstar =$ to play

• 1 **♣** - 2 **♣** - 2 **♥** = limit plus raise of clubs

• 1  $rac{1}{rac{1}{rac{2}{rac{1}{ra}$ 

•  $1 \div - 2 \div - 2NT =$  natural and invitational with the majors stopped

• 1  $\clubsuit$  - 2  $\clubsuit$  - 3  $\clubsuit$  = natural, competitive raise

• 1  $\Rightarrow$  - 2  $\Rightarrow$  - 3  $\diamond$  (or 3  $\checkmark$  or 3  $\diamond$ ) = splinter raise of clubs with a singleton in the bid suit

• 1 -2 - 3NT = to play with the majors stopped

• 1  $\cdot 2$  - double = intent to double either 2  $\cdot 0$  or 2  $\cdot 0$  or both

**Second.**—How about if partner opens  $1 \blacklozenge$  and RHO overcalls  $2 \blacklozenge$  (Michaels for Majors).

•  $1 \blacklozenge - 2 \blacklozenge - 2 \blacktriangledown =$ limit plus values with 5+ clubs

• 1 • - 2 • - 2 • = limit plus raise of diamonds

•  $1 \\ \bullet - 2 \\ \bullet - 2NT =$  natural and invitational with Majors stopped

•  $1 \blacklozenge - 2 \blacklozenge - 3 \clubsuit =$ to play

•  $1 \blacklozenge - 2 \blacklozenge - 3 \blacklozenge =$  natural, competitive raise

•  $1 \leftarrow 2 \leftarrow 3 \lor$  (or  $3 \leftarrow 3 \leftarrow 3 \lor$ ) = splinter raise of diamonds with singleton in bid suit

•  $1 \bullet - 2 \bullet - 3NT =$  to play with Majors stopped

• 1 • - 2 • - double = intent to double either 2 • or 2 • or both

Third.—Now let's say partner opens 1 ▲ and RHO overcalls 2NT (minors).

• 1  $\bigstar$  - 2NT - 3  $\bigstar$  = limit plus strength with 5+ hearts

• 1  $\bigstar$  - 2NT - 3  $\blacklozenge$  = limit plus raise of spades

• 1  $\bigstar$  - 2NT - 3  $\blacklozenge$  = to play

• 1  $\bigstar$  - 2NT - 3  $\bigstar$  = natural, competitive raise

• 1  $\bigstar$  - 2NT - 3NT = to play with minors stopped

• 1  $\bigstar$  - 2NT - 4  $\bigstar$  (or 4  $\bigstar$  or 4  $\bigstar$ ) = splinter raise of spades with singleton in bid suit

• 1  $\bigstar$  - 2NT - 4  $\bigstar$  = to play (preemptive)

• 1  $\bigstar$  - 2NT - double = intent to double either 3  $\bigstar$  or 3  $\bigstar$  or both

And finally.—This time partner opens 1♥ and RHO overcalls 2NT (minors).

• 1 rightarrow - 2NT - 3 rightarrow = limit plus raise of hearts

• 1  $\checkmark$  - 2NT - 3  $\blacklozenge$  = limit plus strength with 5+ spades

•  $1 \bullet - 2NT - 3 \bullet =$  natural, competitive raise

•  $1 \checkmark - 2$ NT -  $3 \bigstar =$ to play

•  $1 \bullet - 2NT - 3NT = to play with minors stopped$ 

•  $1 \neq -2NT - 4 \Rightarrow (or 4 \Rightarrow) = splinter$ raise of hearts with singleton in bid suit

•  $1 \checkmark$  - 2NT -  $4 \checkmark$  = to play (preemptive)

•  $1 \checkmark$  - 2NT - double = intent to double either  $3 \clubsuit$  or  $3 \blacklozenge$  or both

Notice the difference between the cue bids. The higher-ranking cue bid always shows the higher ranking of "our" two suits and the lower cue bid always shows the lower ranking suit. Hence the name "Unusual over Unusual."

# Examples Of Unusual Over Unusual In Action

In each example north deals and opens the bidding as indicated. RHO makes a two-suited overcall, such as Unusual NT or Michaels. We'll assume neither side is vulnerable and that we're playing matchpoints (although bidding would be the same at IMPs).

(1) N: AJx/VKxx/ KQxxx/ KJx S: Axxxx/VAxx/ AQTxx
1 (North) - 2 (East: Michaels, both Majors) - 2 (South: limit plus values with 5+ clubs) - pass (West) - 3 ♣ (North) - all pass

(2) N: ★x / KJxx / ★AQxxx / ★KJx
 S: ★KJxxx / Qxx / ★x / ★Axxx
 1 ◆ -2 ◆ (Michaels, Majors) - double 2 ↓ (Wett)

2♠ (West) - pass - pass - double - all pass. (Partner leads a trump and declarer, with ▲AQTxx/ATxxx/◆xx/♣x, plays well to go down 500.)

(3) N: ▲xx / Kxx / ◆Qxx / ♣AKJxx
 S: ▲AQT / QTx / ◆KJxx / ♣xxx

1 - 2 (Michaels, Majors) - 2NT (natural and invitational) - pass - 3NT - all pass

(4) N: Axx/ Axx/ Qxx/ AKJxx S: AKTx/ Kx/ Ax/ QTxxxx
1 - 2 (Michaels, Majors) - 3 (splinter raise of clubs) - pass - 3 (control) - pass - 4 (still interested in slam, second round control) - pass - 4NT - 5 (1 key card) - pass - 6 - all pass

(5) N: AQJxx/ Vxx/ AQxx/ Kxx
S: AKx/ Vxx/ Kxxx/ Axx
1 → - 2NT (Unusual for lower, hearts and clubs) - 3 V (limit plus raise of diamonds) - 4 V - pass - pass - 5 ◆ - all pass

(6) N: AQJxxx/♥xx/♦Axxx/♣KQ
S: Ax/♥AQJxxx/♦ xx/♣xxxx
1 - 2NT (Unusual for minors) - 3♥
(to play) - all pass

- (7) N: AQxxx/♥Kxx/♦Axxx/♣x S: Ax/♥AQJxxx/♠xx/♣Kxxx
  1♠ - 2NT (Unusual for minors) - 3♣ (invitational with 5+ hearts) - pass -3♠ (nice hand for hearts with diamond control) - pass - 3H - pass - 4H - all pass
- (8) N: AQx/VKx/ Kxx/AJTxx
  S: Ax VJxx AQJxxx AXX
  1NT 2 (Majors) 3 V (invitational with 5+ diamonds) pass 3NT all pass

(9) N: AKx/VAKxxx/ Tx/ xxx
S: Axx/Vxx/ AQJxxx/AQx
1 → - 2 → (Michaels, spades and unspecified minor) - 3 ◆ (Unusual over Unusual does not apply because the opponent's overcall does not show two specific suits; 3 ◆ is natural and forcing) - 3 ▲ (spade values) - pass - 3NT - all pass

### Summary

Unusual over Unusual is an effective, simple convention to add to your arsenal. It only applies when an opponent has bid two specific suits. Cue bidding the lower ranking of his suit shows limit plus values in the lower of opener's suit and the remaining suit. Similarly, the higher ranking cue bid shows the higher of "our" suits. If an opponent has overcalled a two-suiter by using a bid that identifies only one of the two suits, handle that interference as if that suit had been bid naturally. For additional insight into Unusual over Unusual, see Chapter 12.3 of Washington Standard by Steve Robinson.

Jeff Roman lost a heartbreaker in the round of 16 in the Spingold. ### Committee Action XXXVIII— A Question of Alerting (Part One)

### by Rich Colker

Among the most common questions I am asked are those relating to the Alert procedure. These often involve the ethics and the mechanics of Alerting, the information conveyed by an Alert (or a failure to Alert) and the proper way to deal with the events that follow.

It will be helpful in what follows to keep in mind several things. First, the purpose of the Alert procedure is to inform the opponents that a call has been made that has a hidden meaning or implication of which they may not be aware. Second, neither of the players on the Alerting side is entitled to "hear" the Alert nor is a player on a side which has failed to Alert entitled to "not hear" the Alert. Third, the laws prohibit a player from basing any call or play upon information gained from partner's answer to an opponent's question. (You are allowed to "hear" the question itself, however.) Fourth, you are required by law to correct (at the appropriate time and in the proper manner) any misinformation which might have been caused by an inappropriate Alert or failure to Alert. And fifth, proper ethical conduct begins with you recognizing your responsibility to act accordingly. Let's examine each of these points more closely.

The opponents are entitled to all of the information that you and your partner have regarding what your bids mean (or imply). Law 40B states: "A player may not make a call or play based on a special partnership understanding unless an opposing pair may reasonably be expected to understand its meaning...." Often, the only way you can convey such information is through an Alert.

Suppose, for example, your 1 • response to your partner's 1 • opening denies a 5-card major and otherwise says nothing about diamonds. It is Alertable. How else can the opponents reasonably be expected to know that you could hold a singleton or a doubleton diamond for your call? Similarly, if the auction proceeds:

and you play Support Doubles (a double of 2\* by you at your second turn would have shown 3-card spade support), your pass of 2\* must be Alerted. In this case the pass itself is not a special convention or treatment but your failure to double has hidden implications. (You could not have made a penalty double and you probably do not have 3-card spade support—at least not that you wished to show.)

Now suppose you hold ▲Qxx ◆Axx ◆KQxx ♣Jxx and the auction goes as above. Partner Alerts your pass of 2♣ which reminds you that you are playing Support Doubles. LHO passes and partner now bids 2♦ which is passed back to you. Should you bid 2♠? Absolutely not! Alerts are for the opponents' ears and their ears only. You are not permitted to "hear" your partner's Alert in the sense that you may not take advantage of the information which it contains. Since you obviously forgot that you could make a Support Double and since equally clearly partner's Alert awakened you to that fact, you may not now take advantage of your newly found knowledge. You must act as though partner had not Alerted your pass and go quietly.

What would happen if you did bid 2 and that ended the auction. If partner showed up with  $\bigstar$  Axxxx  $\forall x \blacklozenge$  Axxx xxx and both  $2 \land$  and  $2 \land$  make three (with the A Kx onside) you would not be allowed to keep your good result. The opponents would call the Director who would rule the contract back to 2♦ making three (+110 for the opponents). In addition, if you are an experienced player who the Director judges should have known better than to take advantage of the unauthorized information he could also assess a procedural penalty against you (1/4 board at matchpoints or 3 imps at teams) for taking improper advantage. In addition, if you are so foolish as to appeal the ruling, the Appeals Committee should find your appeal to be without merit and penalize you again for your failure to learn your lesson. And, if there is evidence of a history of such actions on your part, a Conduct and Ethics Committee might even be convened which could impose an even more severe punishment. The possibilities include a probationary period or even a suspension.

And what if you bid 2 and caught your partner with  $xxxx \forall Kx \diamond AJxx$ xxx and the opponents lead the Aand a spade through your queen-third drawing trumps in four rounds. They then cash five club tricks for down four—a cold bottom! In that case you would keep your poor result and you could still be subject to a more severe punishment from a Conduct and Ethics Committee. Crime doesn't pay.

Suppose you hold  $AJx \forall Kx AQxxx Axxx and the auction proceeds:$

#### \*Not Alerted

The failure to Alert your double is a sure sign that this partner has forgotten that you are playing Support Doubles. Therefore, partner has pulled what he believed to be your "penalty" double of 2\* back to spades. If partner holds something like AQTxxxx ♥Qxx ♦Kxx ♣x or ♠Qxxxxxx ♥Qxx ♦Kxx ♣—, 4♠ could be cold. Even if he produces some miserable holding such as ▲QTxxxx ♥Qxx ♦Jx ♣xx, he would have to be quite unlucky to go down at the three level. If a raise to  $3 \bigstar$ seems appropriate to you-wrong! If partner had Alerted your double you could raise (at your own risk). However, his failure to Alert makes the raise even more attractive and with that information present the law says you may not choose "...from among logical alternative actions one that could demonstrably have been suggested over another ... " (Laws 16A and 73F) by the unauthorized information. As before, any attempt to do so should at least lead to a score adjustment and possibly to a disciplinary penalty as well
