Presidents' Message

One of the consequences of this reduced publication schedule is the fact that a full four months has elapsed between the time that I drafted the last President's column (1 June) and the time that this Newsletter is mailed to the membership (1 October). In addition to all my other writing issues (just ask Lucy and Margot who work very hard to edit my pearls of wisdom!), this long interval poses a special challenge to keep this column timely and relevant. That said, summer has finally ended - and it was a hot and very humid summer! The September NVBA Sectional was very successful, with over 420 tables in attendance. I hope everyone had a great time, and that you'll come back and play again in October. Let's look at some of the issues that will engage this President and the NVBA Board in the coming months (besides the Holiday Party!).

As you read this column, I will have begun my fifth year as the "Bridge Advisor" to Thomas Jefferson High School (TJHS). In the first four years, I had the great satisfaction of watching as these young men and women developed into some fine bridge players. The graduating seniors of the Class of 2005 included players who may well become household names in the bridge world for years to come. I won't mention all of them by name, but Robert Brady, Brendan Conway, Ben Pollack and David Banh were among the most dedicated and competitive of those 60-odd students who gathered every Friday for two hours of bridge. David Banh, who served as the Youth Advisor to the NVBA Board, was inducted into the Bridge Junior Hall of Fame, and received the singular honor of being named the ACBL King of Bridge (see the article on "King David" on p. 47 of the September 2005 ACBL Bridge Bulletin). The King of Bridge award is a distinct honor that includes a \$1,000 scholarship. Some of the past winners, including Jeff Meckstroth, Robert Levin, Martha Katz and Eric Greco, are among the most significant players in the bridge world today. David was also president of the TJHS Bridge Club, a position that will be filled this year by Annie Martin. I will work with the Board to find a replacement for David as the NVBA

I am pleased to note that the Unit's Intermediate/Newcomer (I/N) bridge game on Thursday night continues to thrive. The I/N game was begun in February 2004 under the sponsorship of Ron Kral. Since then, Ron and a host of volunteers continue to contribute time every week to support and grow this critical game. The I/N game draws about 8-10 tables in a typical week and forms the basis for new and returning players to improve their bridge skills in an appropriately graded environment (maximum of 199 MP). In any given week, I routinely enjoy the added flexibility of balancing the numbers in both the Open and I/N game to maximize the playing enjoyment of both games. Last week, Ron reported that three pairs chose to "play up" in the Open Game, which is one of the goals of the I/N program. The I/N population will help the Unit to increase the B and C field of the Open Game, and in conjunction with other initiatives, will help ensure the strength of the NVBA membership, as well.

The Jack of Hearts

f it ain't broke, don't fix it. This tidbit of undeniable wisdom was probably first uttered on a farm around the start of the Industrial Revolution but you still hear it. Unlike some idioms, its validity has stood the test of time. By comparison, when was the last time you had a flat tire and had some passing visionary yell at you to get a horse? But you still hear, if it ain't broke... Why? Probably because even today, a century and a half later, there are some who can't resist the temptation to try. Enter the ACBL, which, at the recent Summer North American Bridge Championships (NABC) in Atlanta, decided to experimentally change the traditional game times of 1 PM and 7:30 PM for primary events to 10 AM and 3 PM or 4:30 PM.

The three annual NABCs produce big time revenue for the League. This has been especially true in recent years. During the 1970's, only six of the twenty non-summer NABCs reached 10,000 tables. During the 1980's, this number doubled. Of the 47 NABCs since the start of the 1990's, only six have missed the mark. Time for a fix. Let's see if we can't alter the winning formula. True, we have an aging population. We can try to attract younger people to the game, and we can try to accommodate the elderly. In fact, we have been doing both for many years and doing it quite successfully. We've been making good headway with youngsters (see the recent World Junior Championships in Australia). And for years, we've been holding events either limited to seniors, or at times more attractive to them. Gee, maybe that's why business has been good. What to do! I've got it! Let's force everyone, young and old, to play when the seniors play. Let's have everyone done playing and tucked into bed by 8 PM. Let's protect everyone from the dreaded night people. Let's face it. The seniors didn't get to be seniors by being stupid. Up with the sun, down with the sun. That's the ticket! Get a horse!

Despite the schedule, attendance in Atlanta was decent. For a look inside the numbers, please read Nadine Wood's column in the next TableTALK. Lots of NVBAers went, and some even tasted success. Bobby Gookin (Mixed BAM and Open Swiss) and Ai-Tai Lo (LM Pairs and Spingold) led the way in national overalls. David Banh had our highest fin-

Helpful Hints to Winning Bridge by Ron Kral

n the years I've been teaching bridge, I've noticed an interesting phenomenon - I see beginning players repeating the same mistakes again and again in routine situations. Players would bring me a hand and ask about it. I'd answer the question with more questions - "What was the bidding? What was the opening lead? What was the vulnerability?" Then I'd launch into a long-winded explanation trying to cover all the bases and nuances of the situation. The student then gets a deer-in-the-headlights look and mutters, "Why is this so complicated? Can't you just give me a simple rule I can remember and use at the table?" After hearing this over and over, it finally sunk in. I started thinking, "Maybe they're right. I'm not helping them become better bridge players by explaining every twist and turn of the problem." At this stage of their game, they'd benefit more from knowing what's right to do most of the time instead of struggling to understand the nuances of what to do in every possible situation."

Upon further reflection, I believe there are a number of bridge problems where a simple answer, easily remembered, would dramatically improve many people's game, whereas a complex answer is confusing and soon forgotten. If you start out applying the simple rule <u>every</u> <u>time</u>, you will get good result <u>most</u> of the time. Eventually the complexity will become apparent and you can move beyond the simple rule.

This is not a new idea. In 1906, Vilfredo Pareto observed that 80% of Italy's wealth was held by 20% of the population. This "rule" has become known as "Pareto's Principle," or the "80/20 rule," or "the vital few and trivial many rule." It has found application in numerous different environments.

I've agreed to write a series of columns based on this concept as applied to bridge. To paraphrase, "if you learn 20% of how to handle a bridge problem and apply that knowledge 100% of the time, you'll 'get it right' 80% of the time." For the moment, ignore learning the difficult 80% that achieves a better result the remaining 20% of the time.

Let's start with an easy one.

WHEN MAKING YOUR OPENING LEAD, <u>NEVER</u> LEAD A LOW CARD AWAY FROM AN ACE AGAINST A SUIT CONTRACT.

I see beginners make this mistake this time and time again. What often happens is that declarer wins the King in his hand - a trick he could never make without your help. Sometimes declarer even makes a SINGLE-TON king good and you NEVER get your ace! As you might expect, experienced players occasionally break this "rule". Sometimes it's a spectacular success, but often it backfires. DON'T DO IT! Talk to your partners and make the agreement that neither of you will EVER do it. If you must lead a suit headed by the ace, lead the ace (NOTE: leading an unsupported ace at trick one is usually a bad idea).

If you and your partner agree NEVER to lead small from an ace at trick

one, your defense will improve. Here's why:

You know #1: If partner leads a card (not the ace) at trick one against a suit contract, he <u>doesn't</u> have the ace of that suit.

You know #2: If partner doesn't lead the suit he bid, he likely has the ace and doesn't want to lead it (and, he cannot lead small based on your agreement).

You know #3: When playing against competent defenders, if Left Hand Opponent leads LOW from a suit at a suit contract, he <u>doesn't</u> have the ace.

Here are some examples:

Example #1: Partner leads the $\mathbf{v}5$ after bidding spades and being supported by you. Why is partner leading hearts instead of spades? It's likely he has the $\mathbf{A}A$ and doesn't want to lead it (he also doesn't have the $\mathbf{A}K$. If he had both the $\mathbf{A}A$ and $\mathbf{A}K$, he'd have led the $\mathbf{A}A$ - a GOOD lead holding BOTH top honors). If you can't see the $\mathbf{v}A$ in dummy and you can't see it in your own hand, you KNOW declarer has it.

Example #2:

Bidding: 1 ▲ P 4 ▲ All Pass Contract: 4 ▲ Partner's Lead: ♥5

Dummy's Hearts: 986 Your hearts: KJ7 suit contract, and we have an agreement to never under-lead aces at a suit contract, we now know who has the ♥A - declarer. However, we don't know who has the ♥Q. Playing the ♥K will not help our side. Declarer will simply win with the $\, {\bf v} A$ he's known to possess. However, putting in the vJ will elicit some important information. If declarer wins the $\mathbf{v}A$, we know partner has the $\mathbf{v}\mathbf{Q}$ (declarer would have won with the $\mathbf{v}Q$, if he had both it and the $\mathbf{v}A$). If declarer wins the $\mathbf{v}Q$, we now know six high card points in declarer's hand (the $\forall A$ and the $\forall Q$). If declarer opened the bidding, we now know just about half of his High Card Points.

Important note #1: It <u>is</u> OK to lead small from an ace at trick one if the contract is NoTrump. In fact, this may be your best lead.

Important note #2: It's often right to lead small from an ace in the MIDDLE of the hand.

2005-2006 North American Pairs District 6 Finals

The District 6 Final for all flights will be held October 8-9, 2005. You must be a member of a Unit in District 6 and have qualified for the event at the club level to play in the District 6 Final.

The Open Flight Finals will be held at the Knights of Columbus Hall (KOCH), 5115 Little Falls Road, Arlington VA. Game times will be 1:00 and 7:00 on Saturday, October 8 and 11:00 and TBA on Sunday, October 9. Mid-chart conventions will be allowed in the Open Flight only.

The finals for the Non-Life Master (NLM up to 500 MPs) and 0-2000 flights will be played at two sites: the KOCH in Arlington (at 1:00 pm and 7:00 pm on Saturday, October 8 and 11:00 am and TBA on Sunday, October 9) and the Williamsburg Marriott, 50 Kingsmill Road, Williamsburg, VA., on the same dates at 10:00 and 3:00 on Saturday and 10:00 and TBA on Sunday, the same times as the sectional events are held in Williamsburg that weekend.

NLMs and players with 0-2000 MPs may play at the site of their choice.

Three pairs from each flight will qualify to represent District 6 in the National finals, which will be held during the Spring 2006 NABC in Dallas, TX. For the NLM and 0-2000 players, the pair finishing first overall at each



site will qualify for the National final. The formulas for qualifying the third pair and determining the order of qualification will be announced before the start of the event. The Open Final will be held at the Dallas NABC on March 29-30, 2006; the 0-2000 and NLM Finals will be held in Dallas on April 8-9, 2006.



The winners of each flight are reimbursed by the ACBL for airfare and three hotel room nights apiece to attend the National Final. Second place pairs receive airfare from the ACBL and \$200 apiece from District 6 to subsidize hotel expenses. Third place pairs receive \$300 apiece from District 6. Membership dues or Life Master service fee must be current and continuous from the start of the District Final competition to the completion of the North American Pairs Final at the NABC in order to play in the National Final.

Making a List - Checking It Twice Introducing The New Unit 218 Recorder - Jeff Roman

H aving recently taken over the task of Unit Recorder for Northern Virginia from Bette Dudka, who has filled that role for the NVBA exceptionally well for as far back as anyone can remember, I thought it would be a good idea (okay, His Cardillo-ship hounded me until I agreed) to write a paper about the position, describing what the Recorder does, and in some cases to inform people that the process exists.

What is a Recorder? Well, if the director is the Conduct and Ethics cop on the beat, the Recorder is the FBI. Reports of either misbehavior or suspicious activity are gathered and evaluated, in some cases to try to nip a problem in the bud or to correct an ongoing problem. In some cases it is just to keep the incident on file to wait and see if corroborating reports come in.

How does the Recorder get involved? Both in cases of misbehavior and suspected underhanded activity, whether the Director was summoned or not, a player may choose to fill out a "Player Memo" (available from the director of the game). This form gives you a chance to describe what happened at the table, and what your concerns are with regard to what happened. You can then either hand the form directly to me, or hand it to any director, who will see that I get it. The important part of this is that the Recorder cannot be effective unless players take the time to report incidents that should be reported!

What happens then? Well, that depends. In cases of misbehavior, typi-

cally I will have a chat with the person or persons involved, inform them that their conduct was disturbing enough that they were reported, remind them of our commitment to the Zero Tolerance policy, and advise them that repeated incidents of this kind could lead to a formal C&E hearing, with potentially dire consequences. Cases of suspected cheating will sometimes be handled in the same way, in the hope that letting the person know that they are being watched will stop it, and sometimes will be filed away to see if corroborating evidence comes in.

The bottom line - Conduct: We all understand that things can get intense at the table, but, duplicate bridge is a social event first, and as a society we insist that our players act accordingly. So, while I don't want to be inundated with petty complaints, disruptive behavior should be reported, so that I get a chance to modify the behavior of the person or persons involved.

The bottom line - Ethics: The bad news about cheating is that it is utterly easy to do, the good news is that it's impossible to get away with for any extended period. The reason is that eventually, the cheating will lead to doing something abnormal, but, successful. Once and you got lucky. Twice and we're watching you. After that...well...




