President's Message

S I PREPARE this next President's Column for the October – December newsletter, the summer is entering its final weeks. The Alexandria Regional 2006 is in the books, the Hunt Valley Regional is underway and, in no time at all, I will begin my sixth season as the Advisor to the Bridge Club at Thomas Jefferson High School for Science & Technology (TJHSST).

During the summer quarter, the NVBA Board met in June and July, but not in August. Coupled with the Annual Meeting in May, in lieu of a 'reg-

ular' Board meeting, not a lot of Board activity took place from April though August. At the June meeting, the Board reaffirmed the existing policy which allows the use of midchart conventions at all NVBA-sponsored Flight A, Flight A/X, Open and Open Stratified events. In addition, the Board approved the establishment of a Unit Statistician position. Paul Krueger agreed to fill this new position. In this capacity, Paul will use historical data drawn from several sources, as well as the current operational and financial data, to create multi-year trend reports. The hope is that these reports will assist the Board in better defining the long range attendance and profitability of the NVBA, and serve as an additional guide in determining Unit pricing and financial soundness. While all of the financial data from recent years indicates that the Unit profitability is stable, if not increasing slightly, I would like to establish a few simple metrics that can be extended backwards as far as data are available. I'll have more to report on this effort in my next column.

In addition to the usual business items on the agenda, at the July Board meeting, Alexandria Regional Tournament Chair (and NVBA Vice-President) Margot Hennings reported that attendance at the Regional was higher than last year, mostly due to increased Intermediate/Newcomer (I/N) participation. In an effort to maintain that increased I/N attendance, Ron Kral received approval from both the NVBA and the WBL Boards to send thank you letters to the I/N players at the Regional, and invite them to participate in club, unit and other regional events.

Jennifer Lin, the Youth Advisor to the NVBA Board, reported at the July Board meeting on the successful World Junior Bridge Camp that was held in Piestany, Slovakia from 3-10 July. Jenny, David Banh and Robert Brady all attended from this area, and District 6 provided funds to offset half of their travel expenses. I am pleased to note that David and Robert were two of the TJHSST students that participated in the Bridge Club during all four of their high school years. I am excited about continuing the Bridge Club in the 2006-07 school year, and the possibility of attracting and developing future players to join the growing ranks of these fine youth players.

Although my personal schedule did not allow participation at the Chicago National, I look forward to the fall NVBA and WBL Sectionals and a chance to compete with friends at these local, but exciting, events. The Sectionals are the most profitable of all the NVBA events, so maintaining and increasing attendance at the Sectionals is vital to

GRAND NATIONAL TEAMS 2006-2007

It's time to get out to your local club and qualify to win a subsidized trip to Nashville, TN, at the Summer 2006 NABC to represent District 6 in the national finals of this grassroots competition.

ALERT

Due to more stringent residency requirements, any individual who is unsure which District he/she is a resident of as of September 1, 2006, must seek clarification from the ACBL Credentials Committee prior to the start of the event.

The club qualification period begins in October, 15, 2006 and extends through April 2, 2007. District-level competition for all flights except the 0-5000 flight begins in February. So make sure you qualify early. However, you can go out and play as often as you want with whomever you want!!

Once again, the competition will contain four flights at the District level. The **Open Flight** is open to all players; **Flight A** is limited to players with 0-5000 master points; **Flight B** is limited to players with 0-2000 master points; and **Flight C** is limited to Non-

On the plus side were the elevators. I never had to wait ten minutes for one. I never had to go up to go down, even 15 minutes before game time. Hospitality got mixed reviews, both qualitatively and quantitatively. There were nights when they ran out and others when the players took one look and passed. Sort of reminiscent of the lady complaining about a restaurant: "The food isn't good and the portions are so small." Still, neither bad playing conditions, lack of success, nor bad weather kept a smile off my face. You just couldn't ask for a better host than the Windy City, to which the total table count of 13,373 attested.

Others with national overalls were Kenton Schoen (0-5000 LM Pairs and 0-5000 GNT), Ai-Tai Lo and Alan Schwartz (LM Pairs), Sumner Steinfeldt and Ai-Tai again (Fast Pairs and Open Swiss). Regional winners included Hongmo Wang, Lynda Flanger, Ann and Alan Schwartz with Kenton Schoen, and Helene Bauman. Sorry, but I failed to make the list again. Maybe next time I'll toddle.

Life Masters with fewer than 500 master points. Master point eligibility is determined by the ACBL as of August 6, 2006. At the club level, the Open and A flights will be combined.

Master points awarded at the club level are **half red**—an easy way to earn colored points without traveling or changing your normal local playing habits. In the District level competition, the match awards are red and the overall awards are **gold** (Flight C awards 25% gold and 75% red).

Remember, players qualify as individuals at the club level and may form new teams with qualified players for District phase of the competition. What this means is that you can play with all of your friends at the club level no matter what their flight eligibility and then form one or more teams to compete in one or more flights at the District level. So y'all come out and play!

Call your club manager to find out when the club is holding qualifying games. As club dates are made available to the District GNT Coordinator, they will be posted on the District 6 web site, www.districtsix.org.

We will be holding the first weekend of the District finals of Flights B and C at separate northern and southern sites on different weekends, and for the first time ever, two different southern sites. Site 1 will be in Charlottesville, and Site 2 will be in Newport News. **Both will be on the same weekend**. To start your planning process, the dates for the District competition are as follows:

Better Basic Bridge: Third Hand Play

by Ron Kral

N THIS SERIES OF ARTICLES, I'm using the concept of Pareto's principle as applied to bridge. Pareto's principle is the "80/20 rule" or the idea of "a significant few and the trivial many". In the non-bridge world, this means that if you're faced with a problem 100 times, usually just one of the possible solutions will solve the problem 80% of the time. All the other solutions must be known and understood to solve the remaining 20%.

In this series, I present a rule for you to follow **ALL** the time. If you heed this advice, you'll get the best result at the bridge table 80% OR MORE of the time. Of course, bridge is a complex game where a variety of different plays may be correct in any given situation. As you progress, you'll discover the times when it's correct to violate the "rule". But if you start out simply, you can work your way up to the more complex cases.

In the last column, I wrote about **ALWAYS** keeping length with dummy. This time, I'm going to talk about an important defensive concept – third hand play.

For newer players, which card to play after partner's lead and a low card is played from dummy is often unclear. Playing accurate defense requires you to play the "correct" card so partner can use logic to figure out what cards you and declarer hold. You don't want to play the ace of the suit that partner leads at trick one every time. Here's the rule:

<u>ALWAYS</u> PLAY THIRD HAND HIGH WHEN DECLARER PLAYS LOW FROM DUMMY, <u>BUT</u>, PLAY THE SMALLEST CARD THAT WILL "DO THE JOB."

What does it mean to "do the job?" By playing the correct card, you're either going to win the trick, OR, establish a trick for your side to win later.

Of course, these are not 100% plays—BUT, IF you make these plays **ALL** the time, you'll be correct MOST of the time.

Here's a table of examples. The **BOLD/UNDERSCORED** card is the card played:

Lead <u>4</u>	Dummy 83 2	You J <u>T</u> 5	Explanation Play the <u>TEN</u> —the smallest card that will "do the job". If declarer wins with the Queen or King, the opening leader will place the Jack in <i>your</i> hand. Playing the Jack DENIES the ten.
<u>3</u>	T8 <u>6</u>	J9 <u>7</u>	Play the SEVEN . You have all the "filler" cards—the seven is the smallest card that will "do the job." Of course, if declarer plays the eight or ten from dummy, you'll play the nine or Jack respectively. Declarer will have to use at least the Queen to win the trick as long as you cover whatever dummy plays. Partner will then know the cards you hold.

Lead 3	Dummy Q5 <u>4</u>	You AJ2	Explanation Play the JACK. Save the Ace to capture the Queen later. If partner has the King, your side gets <i>three</i> tricks. If declarer has the King, he'll win only <i>one</i> trick in the suit. If you play the Ace on this trick and declarer has the King, he will win <i>two</i> tricks, BOTH the King AND the Queen. The Jack is the smallest card that "does the job."
<u>3</u>	K7 <u>5</u>	Q) <u>T</u>	Play the TEN —the smallest card that will "do the job". When declarer wins the Ace, partner will place you with the Queen and Jack (declarer would have won with the Queen or Jack instead of the Ace if he held one of those two cards).
<u>3</u>	<u>K</u> 75	Q JT	Play the QUEEN —a standard play to tell your partner you have the Jack and ten (OR the singleton Queen). Partner knows he can safely lead the suit again.
<u>2</u>	AQ <u>8</u>	K <u>T</u> 6	Play the <u>TEN</u> . Partner may have the Jack and you'll win two tricks in the suit. If not, you'll get your King later.
<u>9</u>	AQ <u>8</u>	<u>K</u> T5	Play the KING . The nine is NOT a 4th best lead (we can see four cards above the nine)—it's likely a singleton or doubleton. Do not knowingly give declarer a cheap trick with the Jack.
Ţ	A7 <u>4</u>	Q 63	Play the QUEEN —partner may have led the ten from the KT9. If not, declarer has the whole suit anyway and you've lost nothing. If partner has the K/9 remaining, you've held declarer to one trick in the suit.
T	A7 <u>4</u>	K Q 2	Play the QUEEN —the smallest card that will "do the job". Partner does NOT have the Jack (he would have led the Jack if he had the Jack AND the ten), so if you play small, declarer will win a cheap trick with the Jack. When the Queen wins, partner will know you have the King and will lead the suit again later.
Q	54 <u>3</u>	<u>K</u> 2	Play the KING to unblock. Partner has the Jack and likely the ten.

Lead Q	Dummy 54 <u>3</u>	You K <u>9</u> 2	Explanation Play the <u>NINE</u> to encourage partner to lead the suit again. Partner's Queen is already "good enough to do the job," and you don't need to unblock the King with three cards in the suit.
Q	T5 <u>2</u>	K <u>3</u>	Play the <u>THREE</u> . Partner has the Jack, but not the ten (you can see the ten in dummy). If you play the King now, the ten in dummy will set up to win a trick later after partner wins his Jack.
<u>3</u>	86 <u>2</u>	<u>K</u> T4	Play the KING . You'll establish a trick for partner if he's led from the Queen. If declarer has the Ace/Queen, unlucky—your King is dead anyway.

Playing the "smallest card that will do the job" is an extremely important defensive concept. If you follow this rule, the opening leader (your partner) can often tell which cards you hold based on the size of the card declarer must play to win the trick.

Note that there ARE exceptions to this rule, particularly when defending against notrump contracts. Also, sometimes you'll have to guess which is the smallest card you must play to "do the job". If you want to learn more about these exceptions, here's some suggested reading material:
