

Excellent Cardplay by Grand Life Master Alan Schwartz in the Blue Ribbon Pairs and Senior Mixed Pairs Phoenix, AZ North American Bridge Championships November 24-December 4, 2022



Alan thought it was close between bidding 3H and 4H, but decided the flat pattern was worth only 3H. His partner (his wife Annie) went to 4H.

After the ♣K lead, it's reasonable to duck with the 3♣ preempt, playing for clubs 7 -0, and duck again at trick 2. Alan decided to win the ace, hoping clubs were 6-1, which they were. After drawing trump ending in dummy, he led a spade, hoping North would have the KQ and split. When N played low, Alan had no choice but to win the ace. Now he played three rounds of diamonds pitching a spade, went to dummy with a heart spot and led another spade. North, a top player, reflexively won the king. Now N was endplayed and had to give Alan a ruff-sluff, so Alan made 6H, worth 93% on the Board.

Excellent Cardplay by Grand Life Master Alan Schwartz in the Blue Ribbon Pairs and Senior Mixed Pairs (cont'd)



In the Senior Mixed Pairs, the event that Alan and Annie won, Alan made the same play on this hand when S didn't cash clubs after Alan false-carded with the ♣9 at trick 1.

He made 4H for a top on the board when North hopped up with the ◆K when the 2nd round was led, and now had to give Alan a ruff-sluff with a diamond continuation.

District 6 will be running its GNT Finals competition in January and February 2023.

All players may participate. The winners in each Flight will represent District 6 at the Summer NABC in Chicago, IL being held July 13-23, 2023. Teams are not required to club qualify before entering.

The Open Flight competition will be held face-to-face both weekends. For Flight A (0-6000), Flight B (0-2500), and Flight C (NLM, 0-500), the entire event for these three flights is being held ONLINE this year.

The following information is for the Open, Championship flight only. The Open is being held face-to-face on the following dates:

First weekend: January 7-8, 2023, starting at $11:20\,\mathrm{AM}$ on January 7 and $10:30\,\mathrm{AM}$ on January 8.

Second Weekend: February 18-19 (at the NVBA Sectional)

The location for the first weekend will be the Capitol View-Homewood Park, 2929 Edgewood Road, Kensington, Maryland 20895. The second weekend will be held in conjunction with the NVBA sectional at the Fairfax, VA Elks Lodge.

Initial entry fees are \$112 per team, which covers two sessions for the whole team forthe whole first day. To enter the GNT Championship Flight event, write a check payable to District Six and mail it to: Lucy McCoy, 3353 Taleen Ct., Annandale, VA 22003.

Please include the following information with your entry:

The names and ACBL numbers of the players on the team, the GNT Flight you are entering (Championship), and the Captain's email address. Deadline for pre-registration is December 29, 2022.

FLIGHT A (0-6000): The first weekend is February 4-5, 2023. Start time is 11:30 am on BBO both days. The second weekend is February 25-26, 2023. Start time is 11:30 am on BBO both days. Teams must pre-register by January 26, 2023.

FLIGHT B (0-2500): The first weekend is February 4-5, 2023. Start time is 11:30 am on BBO both days. The second weekend is February 25-26, 2023. Start time is 11:30 am on BBO both days. Teams must pre-register by January 26, 2023.

FLIGHT C (NLM, 0-500): The event will be played Sunday only of two weekends. The entire event will be played on BBO. The start time is 11:30 am Sunday, February 5, 2023 the first weekend and at 11:30 am Sunday, February 26, 2023 the second weekend.

Teams must pre-register by January 26, 2023.
