THE ANNUAL NVBA HOLIDAY PARTY, which includes dinner and a bridge game, will be held on Thursday, December 17, 2009, at the Beth El Congregation, 3830 Seminary Rd. in Alexandria, VA. That week is a Sectional Tournament at Clubs (STaC) week, so silver masterpoints will be awarded for placing in this game. Also, the NVBA Board has decided to present a new trophy at this party. The trophy will go to the NVBA member who has participated in the Most NVBA events (Unit game and Sectionals) between the dates of December 1, 2008 and November 30, 2009. The trophy is named the Sara Goodwin trophy in honor of Sara Goodwin who would have received this recognition for her record attendance at NVBA events in 2008, but who died in August before it could be presented to her. Sara played in over 60 NVBA-sponsored games in 2008. Presentation of the Dave Murray award will also now take place at the Holiday Party instead of the Annual Meeting in May. The NVBA Board has decided to present these two awards, which are not related to the amount of masterpoints accumulated by a player in a calendar year, at the Holiday Party instead of the Annual Meeting so that the individuals can be recognized separately from what are primarily ACBL-driven awards.

As in the past, the holiday party is part “catered” and part “pot luck.” Everyone is asked to contribute a food dish...appetizer, salad, casserole or dessert. The NVBA will provide beef barbecue and chicken and beverages, including eggnog (spiked and

Don't Play Bridge!

Surprising advice from a president that has expressed an interest in growth of the game, isn't it? As you might suspect, there is a caveat. We're heading into a flu season that is likely to be worse than normal, and my message is this: If you're sick, stay home.

Be considerate of others and try to avoid spreading infection. The government's one-stop web site (<http://www.flu.gov/>) has detailed info and links explaining the symptoms and prevention. The good news is that swine flu is not as deadly as initially feared. Most people just feel bad, but the obese, infirm, and others are at risk of contracting a potentially fatal case. When last I noticed, the bridge community did not comprise athletes in the prime of life, so we must assume that some of our members, whose pulmonary systems are not as strong as they once were, are especially vulnerable. What can you do? According to the government mitigation plan:

If you are ill, remain at home.
If you have an ill family member, remain at home.

How long? At first, health organizations advised staying home for seven days, but now the best advice seems to be to stay at home at least 24 hours after the fever goes away.

According to the *Washington Post*, most Americans are "not too" or "not at all" worried about the swine flu, no doubt because it was so much milder this spring than was expected. This means much of the public may be caught off-guard this fall and winter, especially if the virus mutates into a more dangerous form.

A fever should certainly trigger the stay-at-home advice, but a person without a fever may be unaware he or she is contagious. There is no reason for overreaction, just common sense, including:

Cover your cough. This shouldn't need to be mentioned, but coughing into one's hands is unsanitary. Flu is spread mainly through coughing and sneezing, so use a handkerchief or shirt, not something that will be handled by others.

Wash your hands...a lot. Believe it or not, I see men who don't wash their hands after using the rest room. One method of contracting this version of the flu is contact with infected swine, and "swine" is the least offensive term I can apply to such people. Club managers should ensure their rest rooms have soap and towels.

Washing hands may not be enough. Get hand sanitizer and use it, particularly before touching your mouth, nose, and eyes. Club managers should have hand sanitizer available.

Be careful grazing at the food tables. If you can't control a sneeze or cough, don't go up there. And as for double-dippers, let's say the "swine" term applies perfectly.

Prepare your partners. A call to cancel a bridge date is not the end of the world. If you feel healthy and your partner doesn't, show up and see if someone else is in the same position or call the club manager.

Club managers are important in controlling the spread of flu. If a club manager is sick, he or she should arrange for a substitute. A sick patron should be advised to go home.

Start planning for disruption of the daily bridge routine now. Be flexible and make protection of others your top priority. Let's get through this coming flu pandemic with as little sickness as possible.

Stratification By Average Option

In the last newsletter, we solicited members' views on whether the Unit should adopt the method of "stratification by average" in NVBA-sponsored stratified pair games. Since there were no strong advocates for changing to this alternate method of stratification, the NVBA Board has decided for the time being that the NVBA will continue assigning pairs to strats based on the player holding the highest number of master-points in the pair.

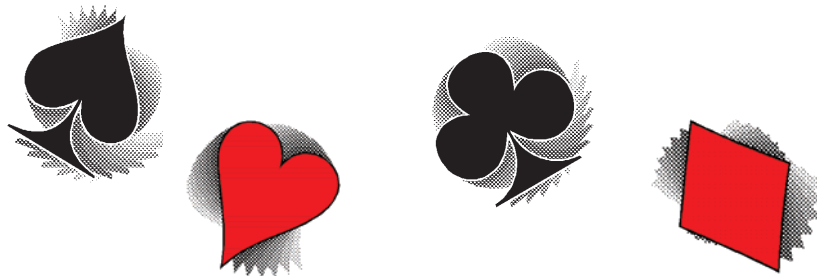

Regional pair events were won by Enid Hughes and Marcia Stein, Al Duncker, William Woodward and John Menzel, Jeff Roman, Sumner Steinfeldt, and Andy Gabrilovitch and Don Geerhart. KO wins went to Cliff Feldman, Marilee Van Arsdale, Tom Musso, Ibrahim Mady, Sara Hilgartner, Saroj Gulati, Stan Schenker and David Milton, Hal Hindman and Mark Chen, Monique Smith, the young people (Dan Emmons, Stephen Drodge, Andrew Rodriguez, and Joshua Holt), the foursome of Al Sitterson, Barbara DiCicco, Eli Arbel, and Joe Leighton, which won twice, Art Hartstein, Anthony and Judith Russo, and Jay Chelrow. Steve Rothman was our only Swiss winner. As usual, you don't see my name, but this time I had a good excuse. I worked the whole time. Almost.

In Memoriam

SARA ELIZABETH GOODWIN passed away on Thursday, August 6, 2009 at the age of 65. Sara was born in Columbia, South Carolina, and, in addition to raising two sons, was an environmental engineer with the U.S. Corps of Engineers and a volunteer at the White House. She was an avid gardener and bird watcher, and without question loved the game of bridge. She achieved the rank of NABC Master, one step away from Life Master, early in 2009. In fact, Sara is the NVBA member who participated in the most NVBA-sponsored events in 2008. Therefore, the NVBA Board has decided to create a new Unit Trophy in Sara's name. The trophy will go each year to the NVBA member who participates in the most NVBA events from December-November, and will be presented at the annual Holiday Party in December. Sara was always a bright and friendly spark in our midst, and her family's loss is also our loss.

LORRAINE PRAIRIE YARMOWICH passed away peacefully on Sunday, August 30, 2009, at the age of 79. Born April 4, 1930 in Alburg, Vermont, she was the daughter of Rene and Sadie (Langlois) Prairie. Lorraine graduated from St. Rose College with a degree in Education. On June 28, 1952 she married Edward Yarmowich. She was a homemaker to Ed and their three sons until his death in 1987. 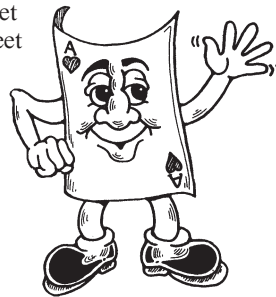

Better Basic Bridge: Floors and Ceilings – Pass, Invite or Bid on?

Whenever you're deciding on a bid, the first thing you do is count your points. Based on that number, you make a bid that shows a range of points. Every bid has a FLOOR (minimum) and many, but not all, bids have a CEILING (maximum). For example, one-of-a-major response to a 1-of-a-minor opening by an unpassed hand usually shows a minimum of 6 HCP but has no ceiling. As the bidding progresses, responder will narrow his range until opener knows responder's ceiling. However, many bids do have a well defined range with BOTH a floor AND a ceiling. The best example is an opening 1NT bid. In modern day bidding, a "strong" 1NT bid generally has a FLOOR of 15 HCP and a CEILING of 17 HCP. There are other NT ranges you can play, but all of them typically specify a narrow range of 3 HCP between the floor and ceiling. These bids are very attractive because you give your partner a very precise definition of your strength with just one bid, and he usually has an easy decision as to how high the partnership should play. So, how do you use this information? When evaluating your hand after partner makes a range limiting bid, you need to add your points to both partner's floor and to his ceiling to decide where the hand belongs. Let's use the strong 1NT opening bid of 15-17 HCP as an example.

After partner opens 1NT, if you hold:

0-7 HCP you KNOW the hand belongs in a partscore. Your 7 HCP plus partner's CEILING of 17 HCP only adds up to 24, therefore you should not be contemplating game. The only question is which

partscore? Depending on your distribution, you might choose to put the contract into a suit contract instead of leaving the contract in 1NT. The responder is in control once partner opens 1NT.

8-9 HCP The hand may belong in a partscore, but may also belong in game. It depends on which end of the range opener has. Partner's FLOOR is 15 HCP. Adding your points to partner's floor = 23-24 HCP – not enough for game. However, adding your HCP to partner's CEILING of 17 HCP results in 25-26 HCP – enough for game. When you're faced with this situation where the high and low cross a boundary, you INVITE to game. Partner rejects your game invitation with a minimum or accepts your game invitation with a maximum.

10-15 HCP With this hand, you KNOW the hand belongs in game. Your 10 HCP plus partner's floor adds up to 25 – enough for game. However, you also KNOW it DOESN'T belong in slam! Your 15 HCP plus partner's ceiling of 17 HCP only adds up to 32 HCP – less than the 33 HCP needed for a small slam. Unless you have a running long suit or other distributional features, the hand just belongs in game, not slam. Do not fall in love with this hand and bid a slam – be disciplined.

16-17 HCP You KNOW the hand belongs in game, but MAY belong in slam. Your 16 HCP plus partner's 15 HCP floor adds up to 31 HCP – not enough for slam. But if partner has the ceiling for his bid, 17 HCP, your 16 HCP plus his 17 HCP adds up to 33 HCP

enough for a small slam. So, you typically invite slam by making a quantitative 4NT bid. Opener will PASS with a minimum 15 HCP (floor) and bid 6NT with a maximum 17 HCP (ceiling), or with a good 16 HCP plus some 9's and 10's in the hand.

18–19 HCP You KNOW the hand belongs in a small slam but does NOT belong in a grand slam. Your 18 HCP plus opener's 15 HCP floor = 33 enough for small slam. However, even if you have 19 HCP and partner has 17 HCP (opener's ceiling), 36 HCP is not by itself enough for a grand slam. So you just bid 6NT and call it a day (or use Stayman or Jacoby transfers en route to a small slam in a suit).

20–21 HCP You KNOW the hand belongs in a small slam, and MAY belong in a grand slam. $20+15=35$, enough for a small slam, but not enough for a grand. But $20+17=37$ is enough for a grand. So bid 5NT which tells partner to bid 6NT with a minimum and 7NT with a maximum.

22–25 HCP You KNOW the hand belongs in a grand slam. Your $22+15=37$. Even if partner has the worst hand possible, you still have enough for 7NT. Just bid it now.

This kind of thinking must be used throughout your bidding system. For example, say you're holding 4 HCP and partner opens 2♣. Well, his floor is typically 22 HCP, so $22+4=26$, and you already know you belong in game. His ceiling is unlimited so you might even belong in slam! Hopefully partner's next bid will define his ceiling and then you'll know how to proceed. Interestingly, when one player knows both the floor and ceiling, HE is captain of the auction since he knows how high the hand belongs. The person holding the better hand is not necessarily captain of the auction.

Whenever partner makes a bid that has a limited range, such as a 1NT response to your 1-of-a-minor opening bid, you mentally add your HCP to his floor AND add your HCP to his ceiling. If BOTH answers fall within the game range (25-32), you should bid game at some level. If BOTH answers fall within the small slam range (33-36), you should end up in a small slam. If BOTH answers are 37 or above, you should bid a grand slam.

The problem arises when the lower answer is in one camp and the higher answer is in a higher camp. In this case, even though you're the captain, you must INVITE either game or slam.

To effectively utilize floors and ceilings, here's what you must know and memorize:

When your partnership's combined assets are **24 points or less**, you belong in a **partscore**.

When your combined assets are **between 25-32 points**, you belong in **game**.

When your combined assets are **between 33-36 points**, you belong in **small slam**.

When your combined assets are **37+**, you belong in **grand slam**.

Finally, you MUST memorize what all the bids in your system promise. Which ones have floors AND ceilings and which ones have just floors. AND you must memorize just WHAT those floors and ceilings are. If I ask you "What does partner's 1NT response promise?" You must be able to tell me without hesitation "6 to 9 HCP". If you don't know what ranges you and your partner have agreed to, your cooperative bidding turns into a guessing game.

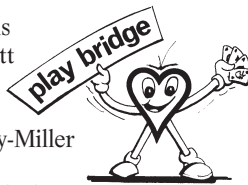
